ROAD TRAFFIC REGULATION ACT 1984 (AS AMENDED) WORCESTERSHIRE COUNTY COUNCIL (WATERSIDE (EAST OF HIGH STREET) UPTON UPON SEVERN) (EXPERIMENTAL PROHIBITION OF DRIVING (EXCEPT FOR ACCESSS) ORDER 2024

Worcester County Council in exercise of their powers under Section 1(1), 2 (1) and (3) and 4 (2) 9 Section 124 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984"), and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed or wait on the following lengths of road in Upton upon Severn in the County of Worcestershire:

Waterside From its junction with High Street, eastwards for a distance of 65 metres.

2. In this order:

"Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988 ("the 1988 Act")

"Pedal Cycle" means a unicycle, bicycle, tricycle or cycle having four or more wheels not being in any case mechanically propelled unless it has an electrically assisted pedal cycle of such class as to be treated as not being a Motor Vehicle for the purposes of the 1988 Act.

3. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to proceed or wait in the length of road referred to in that Article if the vehicle is being used for: -

(c) the vehicle, if it cannot conveniently be used for such purpose in any
