### ROAD TRAFFIC REGULATION ACT 1984 (AS AMENDED) WORCESTERSHIRE COUNTY COUNCIL (BOROUGH OF REDDITCH) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION ORDER 2009 (VARIATION) ORDER 2024 [WAITING/LOADING RESTRICTIONS, REVOCATION OF WAITING RESTRICTIONS ON UNICORN HILL, CHURCH GREEN WEST, REDDITCH]

Worcestershire County Council in exercise of their powers under Section 1(1), 2 (1) to (3), 4(2) and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. The Worcestershire County Council (Borough of Redditch) (Civil Enforcement Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2009 is hereby varied by the attachment thereto of the plan attached to this Order (which has the effect of imposing on the roads and sides of roads identified in the plan attached to this Order Waiting /Loading Restrictions, Revocation of Waiting Restrictions in accordance with the provisions of the Consolidation Order)

#### SCHEDULE

#### Waiting/Loading Restrictions

**Bates Hill – (North Side)** Replace all Limited Waiting 30 mins No Return 4 hours Mon-Sat 8am-6pm with Limited Waiting 45 mins No Return 2 hours Mon-Sat 8am-6pm

**Unicorn Hill – (North Side) No Waiting at Any time – No Loading at Any Time** From a point 73m east of its junction with Plymouth Road to a point 48m east of its junction with Bates Hill.

Unicorn Hill – (South Side) No Waiting at Any time – No Loading at Any Time From a point 35m east of its junction with Bates Hill for a distance of 10m in a Westerly direction. Goods Vehicle Loading only from a point 25m east of its junction with Bates Hill for a distance of 36m in a Westerly direction.

**Disabled Badge Holders only** from a point 11m east of its junction with Bates Hill for a distance of 18m in a Westerly direction.

#### Limited Waiting 45 mins No Return 2 hours Mon-Sat 8am-6pm

From a point 29m east of its junction with Bates Hill for a distance of 36m in a Westerly direction.


**Church Green West – (West Side) No Waiting at Any Time – No Loading at Any Time** From its junction with Church Road for a distance of 20m in a southerly direction. From a point 40m south of its junction with Church Road for a distance of 52m in a southerly direction.

**Church Green West – (East Side) No Waiting at Any Time – No Loading at Any Time** From its junction with Church Road for a distance of 40m in a southerly direction. From a point 56m south of its junction with Church Road for a distance of 30m in a southerly direction.
