The public right of way over the land situate at Hartlebury and shown by a continuous bold line on the map attached to this Order and described in the Schedule to this Order shall be extinguished on the date of confirmation of this Order, and thereupon the County of Worcestershire definitive map and statement shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this Order.

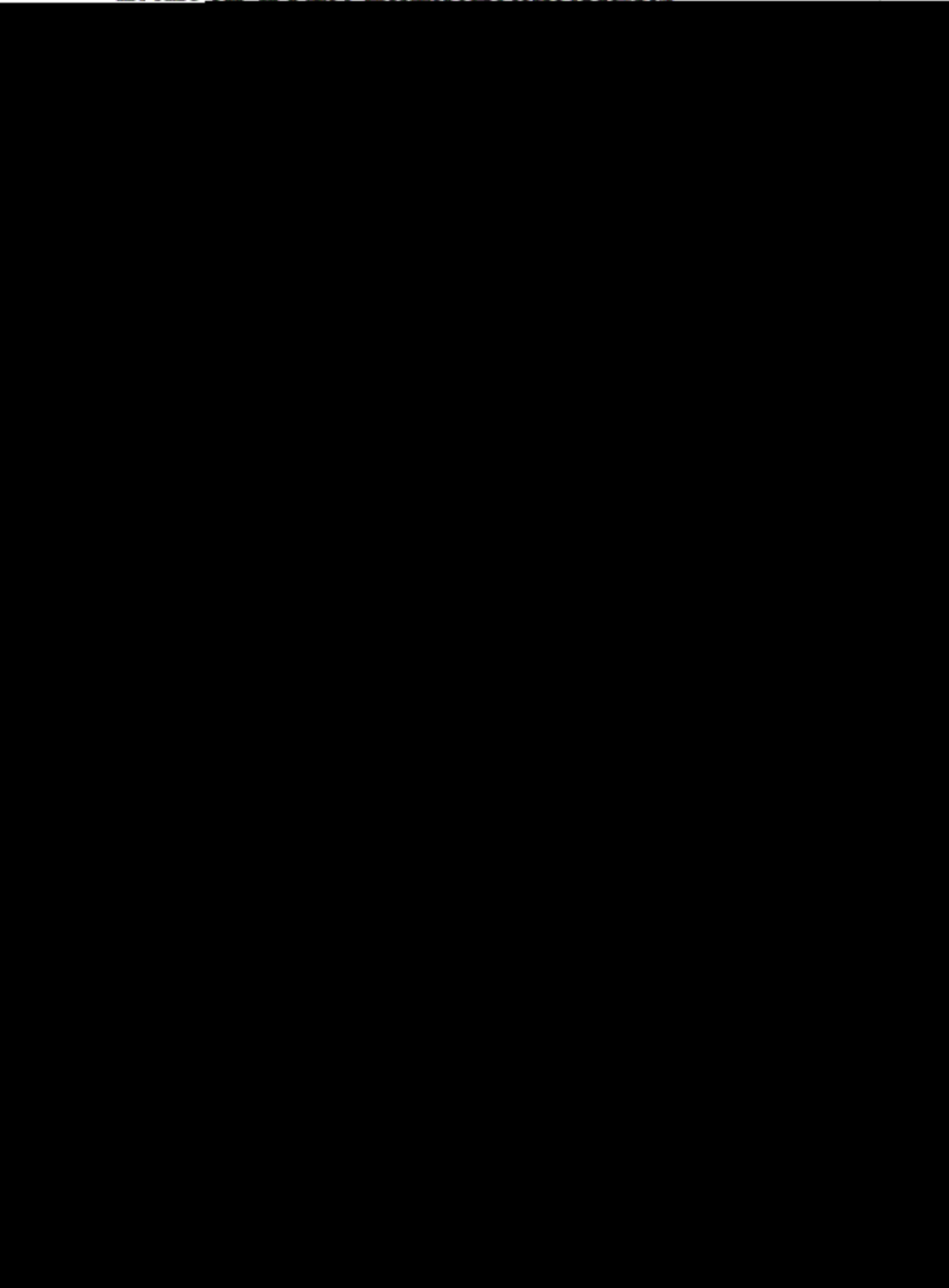

FOOTPATH HR-524 (PART) (FORMERLY FOOTPATH 13)

The length and entire width of footpath HR-524 in the parish of Hartlebury to be extinguished commences at Ordnance Survey Grid Reference (OSGR) SO 8595 7177 (Point A on the Order map); the path proceeds in a south-westerly direction for 16 metres to terminate at OSGR SO 8594 7176 (Point B on the Order map).

The total distance of footpath to be extinguished is 16m.
